 - a. Advancement and propagation of education and learning including establishing, maintenance and support of schools and other educational institutions.









7. MANAGEMENT

- a. - d. At all meetings of trustees, the Chairman or in his absence the Secretary shall preside. If there be sufficient quorum even in the absence of both the chairman and the Secretary those present shall amongst themselves one Trustee to preside. All decisions of the Trustees shall be by a majority vote, and the Presiding Trustee shall have a casting vote in case of a tie of votes.
- e. All proceedings of the meeting of the Trustee shall be recording in a minutes Book kept for the purpose. A separate Book of Resolutions shall also be maintained.
